1. **Tobacco-Free**

To be included on the **Tobacco-Free listing**, your organization must have a written policy stating that the property/campus is **completely tobacco-free (all forms of tobacco including cigarettes and chewing tobacco)** at all times for all employees, visitors, etc.

2. **Smoke-Free**

To be included on the **Smoke-Free listing**, your organization must have a written policy stating that the entire property is **completely smoke-free** OR that the indoor area is completely smoke-free, even though the current state law permits smoking in your facility (such as a place that serves alcohol or has video lottery). "Completely" means that the *entire indoor facility* is smoke-free at all times for all employees, visitors, etc.
